

## REPORT TO A PLANNING MEETING TO BE HELD ON 13<sup>th</sup> MAY 2021

### SOUTH WARWICKSHIRE LOCAL PLAN SCOPING & CALL FOR SITES CONSULTATION

#### 1. PURPOSE OF THE REPORT

To identify possible draft responses to the questions contained within the South Warwickshire Local Plan Scoping & Call for Sites Consultation document.

#### 2. BACKGROUND

Following the decision for Stratford-on-Avon and Warwick District Councils to produce a single South Warwickshire Local plan, the first stage in preparation is a scoping consultation document for public comment.

The decision to undertake public consultation was made at the Joint Cabinet/Executive Committee meeting on 14 April 2021. Once complete, this new Local Plan will replace the strategic policies of the Stratford-on-Avon Core Strategy and Warwick District Council Local Plan. This initial consultation seeks views on the main issues facing the South Warwickshire area, and includes a range of objectives and options to inform where new development should be located and how best growth should be accommodated up to 2050.
